Actilight is a mixture of fructo-oligosaccharides (FOS), which are soluble dietary fibres. FOS are chains of fructose molecules linked to a molecule of sucrose. Specifically, FOS in Actilight® have short chains (degree of polymerization between 3 and 5) and are obtained by enzymatic reaction from sucrose.
